BUENOS AIRES 2018 YOUTH OLYMPIC GAMES NOMINATION CRITERIA FOR VOLLEYBALL EVENTS

Volleyball New Zealand Incorporated ("Volleyball New Zealand")

1. Application of this Nomination Criteria

- 1.1 This Nomination Criteria is issued by the CEO of Volleyball New Zealand.
- 1.2 This Nomination Criteria shall take effect from 1st of August 2017.
- 1.3 This Nomination Criteria applies to:
 - (a) all Athletes wishing to be considered for nomination to the Games Team to compete in the Games in a Volleyball Event; and
 - (b) Volleyball New Zealand, including its Selectors, that wish to nominate Athletes to NZOC to be considered for selection to the Games Team for the Games.

2. <u>Selectors</u>

2.1 **Composition**: The Selectors shall be appointed by the Board of Volleyball New Zealand. The Selectors who will consider nomination of Athletes to NZOC to be considered for selection in the Games Team are:

Tim Cleaver, Antony Joe, Fiona Scrimshaw, Lucy Pomeroy

3. <u>Nomination Procedure</u>

- 3.1 **Conditions of Nomination**: The Selectors may only consider an Athlete for nomination if the Athlete has satisfied the following conditions of nomination:
 - (a) returned a completed Athlete Application to the NZOC, in the form prescribed by the NZOC by the Application Date; and
 - (b) returned a completed Athlete Agreement in the manner prescribed by the NZOC to NZOC prior to the Nomination Date; and
 - (c) demonstrated to the satisfaction of Volleyball New Zealand that they are not suffering any physical or mental impairment that would prevent them from competing in the Games to the highest possible standard; and
 - (d) acted in such a manner so as not to bring the Athlete, the sport, Volleyball New Zealand or the NZOC into public disrepute; and
 - to Volleyball New Zealand's knowledge has not used or administered any substance which, if it had been detected as being present in the Athlete's body tissue or fluids,

- would have constituted doping, or used any prohibited method or committed any other doping offence as defined in Volleyball New Zealand's, the International Volleyball Federation's (FIVB's) or NZOC's Integrity Regulation; and
- (f) be born between 1 January 2000 and 31 December 2003; and
- (g) have participated in a Mandatory Key Event set out in clause 4.2(b)(i); and
- (h) from 30 March 2018 (or an extended date if agreed by the NZOC Board) has provided their name and contact address details to NZOC for the purpose of out of competition drug testing with Drug Free Sport New Zealand.
- 3.2 **Qualification**: New Zealand must qualify for places in an event(s) in accordance with the FIVB's Qualification System for Buenos Aires 2018 Youth Olympic Games ("FIVB Qualification System") and/or FIVB's requirements for the Games. Qualification for a place in any Volleyball Event(s) by an Athlete does not guarantee that Athlete will be nominated or selected to compete in the Volleyball Event(s) at the Games.
- 3.3 **Nomination if Nomination Criteria Met**: Provided the requirements set out in clause 3.1 and 3.2 are met, the Selectors shall nominate those Athletes it considers meet the Nomination Criteria set out below.

4. Nomination Criteria

- 4.1 **Nomination Criteria**: The Volleyball New Zealand Nomination Criteria for nomination to the Games Team is made up of two parts:
 - (a) the Over-Riding Nomination Criteria specified in clause 4.2; and
 - (b) the Specific Nomination Factors specified in clause 4.3.

4.2 **Over-Riding Nomination Criteria**:

- (a) In determining whether or not to nominate an Athlete to Volleyball Events, the Selectors must be satisfied overall that the Athlete:
 - i. is the best Athlete (individually and as part of a team) available for nomination as determined by the best placing in the Trial Event;
 - ii. has a track record of sufficient quality and depth that Volleyball New Zealand believes demonstrates the Athlete (individually and as part of a team) will perform with distinction at the Games;
 - has competed at a Mandatory Key Event finishing with a competitive result;
 - iv. has a programme developed and endorsed by Volleyball New Zealand to prepare them for the Games, and whether they are progressing to the agreed plan; and

- v. is financially committed to attending the Games.
- (b) In determining whether or not the Athlete has met the Over-Riding Nomination Criteria for Volleyball Events in clause 4.2(a) above, the Selectors shall consider the Athlete's performances and results in the Volleyball Event at which they seek to be selected for the Games in the following Key Events during the period 1st August 2017 to 22 July 2018:

(i) Mandatory Key Event

All Athletes must attend a minimum of one (1) of the following Key Events:

- 2018 FIVB Beach Volleyball U19 World Championships;
- 2018 Continental Youth Championships (or a Continental Youth Tour) or
 2018 Asia and Oceania Youth Olympic Games Qualification Tournament;
- FIVB World Tour, Continental Cup, FIVB homologated Continental Tour and FIVB homologated Continental Zonal Tour.

(ii) Trial Event

The Trial Event for the purposes of this Nomination Criteria will be the Beach Volleyball NZ Youth Olympic Games Selection Tournament, which will be held in February 2018 (exact date to be determined).

All Athletes seeking an invitation to the Trial Event must have competed and achieved:

Male:

- A top 10 placing amongst NZL teams at one of the 3 National Beach Volleyball Tour Events in January 2018 or the Senior National Beach Champs in February 2018 (must be partnered with an age eligible athlete); and/or
- A top 6 placing at the New Zealand Age Group Beach Volleyball Champs
 2017 Under 19 grade; and/or
- A top 4 placing at the New Zealand Secondary School Beach Volleyball Champs 2017 senior grade.

Female:

- A top 8 placing amongst NZL teams at one of the 4 National Beach Volleyball Tour Events in January 2018 or the Senior National Beach Champs in February 2018 (must be partnered with an age eligible athlete); and/or
- A top 6 placing at the New Zealand Age Group Beach Volleyball Champs 2017 Under 19 grade; and/or
- A top 4 placing at the New Zealand Secondary School Beach Volleyball Champs 2017 senior grade.

Note: The athletes best placed at the Trial Event, will automatically earn the right to represent New Zealand in the Asia and Oceania Youth Olympic Games Qualification Event.

4.3 **Specific Nomination Factors**: When considering the Over-Riding Nomination Criteria above, the Selectors may also take into account any one or more of the following factors about an Athlete:

- (a) any other performances or results in competitions / events in addition to the Key Events;
- (b) adequate fitness and a commitment to maintain a fitness and training programme as agreed with the applicable coach(es);
- (b) demonstrated good behaviour, including a commitment to training and attendance at training camps;
- (c) demonstrated compatibility with others in a team environment;
- (d) demonstrated compliance with the rules of events and competitions;
- (e) understanding and respect for the obligations that accompany being a member of a New Zealand team when competing at the Games, including respect for team members and support staff;
- (f) willingness to promote Volleyball New Zealand in a positive manner;
- (g) demonstrated ability to take personal responsibility for self and their results;
- (h) proven ability to be reliable; and
- (i) any other factor(s) the Selectors consider relevant.
- 4.4 Permission to Start: In addition, at the sole discretion of the NZOC, Athletes who qualify for nomination in accordance with this Nomination Criteria, on Volleyball New Zealand's request to the NZOC and if they are selected to the Games Team by the NZOC, request permission to start in the Mixed Volleyball Event where there is an available place and where competing in the Mixed Volleyball Event will not have any detrimental effect on the Volleyball they have already been selected for.
- 4.5 **Own Enquiries:** In considering any one or more of the above factors, the Selectors may make such enquiries of the Athlete, or other persons, as they see fit.
- 4.6 **Weight to be Given to Specific Nomination Factors:** The Selectors may give weight to any one or more of the Specific Nomination Factors and, if it does, to apply such weighting to one or more Athletes. No particular factor shall be weighted more or less significantly by reason only of the order in which that factor appears in this Nomination Criteria.
- 4.7 **Extenuating Circumstances:** In any decision regarding the nomination of Athletes to the Games Team, the Selectors may, in their sole discretion, take into account any extenuating circumstances in accordance with clause 5 below.
- 4.8 **Nomination Procedure:** After consideration of this Nomination Criteria, the Selectors shall follow the procedure set out in clause 9 of the NZOC Nomination and Selection Regulation.

5. Extenuating Circumstances

- 5.1 **Extenuating Circumstances:** In considering the nomination of Athletes in accordance with this Nomination Criteria, the Selectors may, in their sole discretion, give weight to any extenuating circumstances which may include, but are not limited to, the following:
 - (a) injury or illness;
 - (b) travel delays;
 - (c) equipment failure;
 - (d) bereavement or personal misfortune; and/or
 - (e) any other factors reasonably considered by the Selectors to constitute extenuating circumstances.
- 5.2 Athlete to Advise: Athletes unable to compete at events, trials, or other attendances required under this Nomination Criteria, must advise the Chief Executive of the extenuating circumstances and reasons, in writing, with as much advance notice as possible and ideally seven (7) days prior to the commencement of the event, trial or other attendance. If the Chief Executive is not notified of any extenuating circumstances in accordance with this Nomination Criteria, then the Selectors have no obligation to rely on such circumstances.
- 5.3 **Medical Certificate:** In the case of injury or illness, Athletes may be required by the Selectors to provide a medical certificate and/or to undergo an examination by a health practitioner/s nominated by the Selectors, and to provide that opinion and/or report to the Selectors. Any failure to agree to such a request may result in the Selectors being unable to consider the injury or illness as an extenuating circumstance.
- 5.4 **Case by Case:** In the case of any extenuating circumstance/s, the Selectors will make a decision on a case-by-case basis.

6. Appeal Procedure

- 6.1 **Nomination Appeals**: An Athlete may appeal to Volleyball New Zealand against their non-nomination to the NZOC by the Selectors provided that the Athlete has returned a completed:
 - (a) Athlete Application to the NZOC by the Application Date; and
 - (b) Athlete Agreement to the NZOC by the Nomination Date.
- 6.2 **Procedures for Nomination Appeals**: Any appeal under paragraph 6.1 must be made in accordance with the procedures set out in clause 13 of the NZOC Nomination and Selection Regulation.

7. <u>Inconsistencies</u>

- 7.1 **NZOC Nomination and Selection Regulation:** In the event there is any inconsistency between this Nomination Criteria and the NZOC Nomination and Selection Regulation, the NZOC Nomination and Selection Regulation shall prevail.
- 7.2 **FIVB Qualification System:** If this Nomination Criteria imposes a higher qualification standard or a lesser number of participants than stated by the FIVB Qualification System, this shall not be regarded as an inconsistency.

8. Amendments to this Nomination Criteria

- 8.1 **Prior to Nomination Date:** This Nomination Criteria may be amended or supplemented from time to time by the Board, before the Nomination Date, provided NZOC has approved the amendment/s and supplement/s.
- 8.2 **Notice:** The Board will give as much notice as possible of any amendment/s or supplement/s made under clause 8.1 to this Nomination Criteria, to persons it considers may be affected by any such amendment/s or supplement/s.

9. Definitions

- 9.1 **Application Date** means 30 March 2018 (or an extended date if agreed by the NZOC Board), by which Athletes must submit a completed Athlete Application in accordance with clause 8.3 of the NZOC Nomination and Selection Regulation.
- 9.2 **Athlete** means a person who wishes to be considered for nomination to the Games Team.
- 9.3 **Athlete Agreement** means the agreement that must be completed by any Athlete wishing to be considered for nomination and selection to the Games Team in accordance with clause 8.4 of the NZOC Nomination and Selection Regulation.
- 9.4 **Athlete Application** means the form set by the NZOC that must be completed by any Athlete applying to be nominated and selected to the Games Team.
- 9.5 **Board** means the Board of Volleyball New Zealand as constituted under the Constitution.
- 9.6 **Chief Executive** means the Chief Executive Officer of Volleyball New Zealand and includes his / her nominee.
- 9.7 **Constitution** means the Constitution of Volleyball New Zealand.
- 9.8 **Games** means the 2018 Youth Olympic Games to be held in Buenos Aires in Argentina from 6 18 October 2018.
- 9.9 **Games Team** means the New Zealand Team at the Games selected in accordance with the NZOC Selection Policy for the Games.
- 9.10 **Key Events** means an international, continental or national competition listed in clause 4.2(b) which is a major or pinnacle event for the sport or is at least the equivalent of a Junior World

Cup or Junior World Championship, and have an equivalent to that which is likely to occur at the Games.

- 9.11 **Mandatory Key Event** has the meaning given to it in clause 4.2(b)(i).
- 9.12 **Nominated Athlete** means an Athlete who has been nominated to the NZOC by Volleyball New Zealand.
- 9.13 **Nomination Criteria** means the criteria made up of the Over-Riding Nomination Criteria and the Specific Nomination Factors, and is also referred to as "this Criteria".
- 9.14 **Nomination Date** means on or before 27 July 2018 (and includes any alternative date as agreed between NZOC and Volleyball New Zealand), by which Volleyball New Zealand must submit any Nominated Athletes to the NZOC.
- 9.15 **NZOC** means the New Zealand Olympic Committee Incorporated.
- 9.16 NZOC Nomination and Selection Regulation means the regulation of NZOC relation to the nomination and selection Process for all Olympic and Commonwealth games, including the Games.
- 9.17 **Over-Riding Nomination Criteria** means the criteria set out in clause 4.2.
- 9.18 **Selectors** means the selectors appointed by Volleyball New Zealand in accordance with clause 2 of this Nomination Criteria.
- 9.19 **Trial Event** means the event referred to in clause 4.2(b)(iii).
- 9.20 Volleyball New Zealand means Volleyball New Zealand Incorporated.
